

Funding will be provided by MERCI subject to the awardee's participation in the training and against the presentation of the required documents and original receipts, all as detailed in this call.

1.1 The applicant is an active student for a Masters/ Doctorate / Post Doctorate degree or a professional technical staff at one of the partner institutions as defined above.



The requested amount to be funded by the Center is to be stated in the abovementioned form for the purpose of participating in the venue/event and is to specify the requested expenses within the framework of this Funding and other funding sources from any other source or entity. Insofar as the supplementary funding sources are not known in full when the application is submitted, the applicant will present the supplementary funding sources in the submission form pursuant to MERCI's demand or immediately upon learning of them, whichever is earlier. Presenting the supplementary funding sources is contingent upon approval of support from MERCI according to this tender.



1. A detailed letter explaining the importance of the applicants participation in the training/event and why MERCI should support participation.



2. The applicant's curriculum vitae.



3. Valid approval of studies from applicant's academic institution.

Selection of supported applications

1. Applications that satisfy the participation conditions will be remitted to the Judging Committee on MERCI's behalf who will review them and select the winning applicants. Every member of the Committee will examine all the applications, excluding proposals from the Committee member's academic institution or others with a conflict of interest (mentors/mentees/joint work etc). Notwithstanding the above, the Committee may refrain from selecting an applicant as a winner, to allow a variety of candidates to win from various disciplines/ departments and different institutions.

















General

- 1. The committee will be entitled to determine the number of support scholarships and the amounts funded in accordance with its discretion and MERCI's budget, provided that each scholarship does not exceed 5,000 NIS. Final approval of the committee's decisions will be given in accordance with the available budget and with the approval of the chairman of the academic and training committee and subject to receiving administrative approval and budgetary approval of MERCI and subject to MERCI's procedures.
- 2. The funding will be awarded to the applicant (s) who will receive one payment by via MERCI in the form of a check or bank transfer to his/her bank account, subject to the following cumulative conditions-
- a. The applicant/s participated in the event/venue to which they applied within this tender and presented MERCI with an official approval of participation as stated above.
- b. The applicant/s presented an e-ticket for travel to MERCI and proof of leaving and re-entering Israel prior and after the event/training.
- c. The applicant/s presented invoices and original receipts to MERCI, against which reimbursements will be issued in accordance with the approved maximum amount.
- d. The applicant/s signed the declarations in Appendix B and Appendix C of this tender. The Funding will be awarded to a candidate or candidates who satisfied all conditions in the Tender Bylaws.


